SCOTTSBURG MAIN STREET REQUESTED THE COUNCIL CLOSE THE INNER SPOTS OF PARKING AROUND THE SQUARE FOR MATERFEST ON JULY 19TH AND JULY 20TH. STANLEY ALLEN MADE A MOTION TO APPROVE THE REQUEST. CHUCK ROSE SECONDED. THE MOTION CARRIED 4-0.
