- A. O'MARA IS FINISHING THE BORING PROJECT UNDER THE RAILROAD.
- B. OPAL DRIVE LIFT STATION CONSTRUCTION HAS BEGUN.
- C. THE PEDESTRIAN SIGNAL AT LAKE ROAD IS BEING INSTALLED TODAY. THE NEXT STEP IS STRIPING AND CLEAN UP WORK TO FINISH UP THE TRAIL PROJECT ON LAKE ROAD.

- F. THE STATE IS HAVING A PRECONSTRUCTION MEETING ON APRIL 17, 2019 FOR THE STATE ROAD 56 AND 31 INTERSECTION PROJECT. THE PROJECT IS EXPECTED TO BEING IN THE NEXT 30 DAYS. PART OF THIS PROJECT REQUIRED THE FOLLOWING FROM THE CITY:
 - a. ELECTRIC DEPARTMENT TO MOVE STREET LIGHT AND SERVICE FROM POLES. THEY WILL COMPLETE THE WORK IN HOUSE.
 - b. WATER DEPARTMENT TO MOVE FIRE HYDRANT AND RELOCATE WATERLINE. THE INDOT CONTRACTOR WILL DO THE WORK AT A COST OF \$42,500.
 - c. SEWER DEPARTMENT TO RELOCATE SANITARY SEWER LINE. THE INDOT CONTRACTOR WILL DO THE WORK AT A COST OF \$22,465.
- G. THE CITY HAS BEEN INVITED TO SUBMIT A FULL APPLICATION TO THE EDA FOR A \$3 MILLION GRANT BY APRIL 22, 2019. THE AWARDS WILL BE ANNOUNCED THIS SUMMER.
