By submission of this application and/or issuance of any permit or approval by the City of Scottsburg or the Scottsburg Building, Planning, and Zoning Commission, the **applicant acknowledges and agrees** to the following:

1. **Responsibility for Compliance:** It is the sole responsibility of the applicant, property owner, developer, contractor, or any other affiliated party to ensure that the proposed project complies with **all applicable federal, state, and local laws, rules, regulations, building codes, environmental regulations, and permitting requirements**, including but not limited to those enforced by the Indiana Department of Environmental Management (IDEM), Indiana Department of Homeland Security, U.S. Army Corps of Engineers, and other relevant agencies.
2. **City's Limited Review and Approval:** The issuance of a permit, approval, or any other authorization by the City of Scottsburg or the Building, Planning, and Zoning Commission **does not constitute a certification, guarantee, or approval** that the proposed project complies with any federal or state laws, regulations, or administrative rules. The City's review is limited solely to matters governed by the **Scottsburg Code of Ordinances** and does not extend to state or federal requirements.
3. **Modifications and Amendments:** Any **modification, deviation, or amendment** from the approved plans or project scope **may require the submission of a new application and issuance of a new permit**. The applicant is responsible for discussing any proposed changes with the Executive Director of the Building, Planning, and Zoning Commission **prior to implementing such changes**.
4. **Enforcement and Stop Work Orders:** Any **violation of applicable local, state, or federal law, code, or regulation** may subject the project to enforcement action, including but not limited to the issuance of a **Stop Work Order** by the City of Scottsburg or referral to the appropriate regulatory agency. The City reserves all rights to take action as authorized under law to protect public health, safety, and welfare.
